The parent or guardian agrees to abide the terms of installment payments (if offered by the League) and agrees to make payments upon scheduled due dates, without a reminder from the **Sugar Land Ice Hockey Department**. If Parent or Guardian fails to remit payment to **Sugar Land Ice & Sports Center** on scheduled due dates; the above player may be suspended from the **Sugar Land Ice In-House League**.
4. Parent and skater assume all risk and danger incidental to ice skating in general, and the game of hockey in particular. These risks and dangers include, but are not limited to, the danger of being injured by pucks, hockey sticks and other players. The parent or guardian also agrees that the **Sugar Land Ice Hockey Department** is not responsible for loss of or damage to any personal property.
5. Full equipment required. **NO EXCEPTIONS**. Street Hockey equipment is not acceptable.
6. Teams may be joined together if a minimum of fifteen players per team is not achieved. Each team will have an average of fifteen (15) players, two goalies and a standby waiting list.
